## Instructions for completing form

### Photo membership card and Access card.

To be on club property you must be in possession of your photo membership card and your access card. Entering and leaving the property and entering the building requires your access card. You are also required to tap in and out of each range when you use it.

### Family membership.

Family membership only applies to the member, their spouse/partner and children under 18 or under 21 while in full time education and still living at home.

Photo ID cards and access cards that open the main gate are only issued to the main member and their spouse/partner that has a PAL. Youth members and spouses without a PAL are issued a membership card that does not have a photo and an access card that does not open the main gate.

#### Multi Year memberships.

Any possible price increases in 2025 and 2026 would not apply to you.

Please note, once paid the future amounts are not refundable. If you move or are no longer able to use the club, we will not refund any of the payments, they will be considered a donation to the club.

#### Prices.

Prices include an annual \$50 maintenance fee. This fee is refundable the following year when you renew if you have volunteered for 2 workdays or other club organised events. Members over 70 or with a disability must provide the club with government issued documentation (without any medical information) such as and disability parking permit or a CRA disability credit, to be pre approved for exemption to this fee.

If you have already paid the maintenance fee for the following year a refund cheque will be issued.

#### CSSA.

Many members also belong to various firearm/hunting organisations and we encourage you to support as many of those organisations as possible to help ensure the future of our sport.

At this club CSSA membership is mandatory. If you are not paying through this club, it is your responsibility to maintain CSSA coverage up to your LTVFG membership expiry date. Your CSSA number, expiry date and how it was paid must be entered.

If you pay your CSSA directly it is important that you inform us as once your payment is made so that we can update your new CSSA expiry date in our records.

Please note, if you have a lifetime membership of the CSSA then it only applies to the individual. For family membership, you will have to contact the CSSA directly for family coverage.

## Minimum information required.

If you know your membership number (on your photo membership card) and your details (address, email, phone, etc.) have not changed, enter membership number, name, family members names (if family membership) and their details, payment amount, payment method, sign and date the form.

If you do NOT know your membership number, enter you name and address (we have members with the same first and last names) family members names (if family membership) and their details, payment amount, payment method, sign and date the form.

If any of your details (address, email, phone, etc) HAVE CHANGED, enter the information specified above plus the changed information in full.

## Methods of Payment.

**Cash** – can only be used when paying in person or when leaving it in the drop box together with your completed form. **Cheque/Money Order** made payable to LTVF & G. Can be used when paying in person, leaving it in the drop box or when sending by mail.

**EMT/EFT** should be sent to <a href="mailto:renewals@ltvfg.ca">renewals@ltvfg.ca</a> A security answer is required. Please write the answer on the bottom of your membership form. Please do not use your name as that information is normally included in the email from Interac. Use something we have on file such as the first 8 digits of your PAL or your CSSA number, your Street name, etc. Ensure your name & membership number are included in the message portion of the EMT. We often receive EMT's from a business name or numbered company and have no idea who they are for.

**Credit or Debit card** can be used in person, to use them online send your completed renewal form and we will send an invoice which includes a link to pay online. **Do NOT send us your credit card number. We do not want or need your card details.**
