### IMPORTANT UPDATES ON THE OIC GUN BAN

**October 30, 2026** is the last day for the amnesty period for individuals to comply with disposal or deactivation requirements.

If you are in possession of a banned firearm on October 30 at 23:59, you will be breaking the law. The government can revoke your PAL/RPAL and confiscate ALL of your firearms. If this happens you will not be able to obtain a PAL/RPAL or legally possess firearms FOR LIFE.
