Instructions for completing form

Photo ID

To use the ranges effective Jan 2020 you must be in possession of your photo ID membership card and your access card.

Access Card.

Entering and leaving the property is via a sliding gate, which requires your access card. Your access card will also give you access to the main building for the bathrooms and indoor ranges. **You must use you access card to tap in and out of each range used.**

Family membership.

Family membership only applies to the member, their spouse/partner and children under 18 or under 21 while in full time education and still living at home.

We are now requesting your child's age because we have found people have included their parents, grandparents, cousins, etc. as family members in the past.

Photo ID cards and gate access cards are only issued to the main member and their spouse/partner if they have a PAL. Youth members are issued a green membership card and spouses without a PAL are issued a non photo ID and both youth and no PAL spouses are issued access cards that do NOT open the main gate.

Multi Year memberships.

We accept memberships up to 3 years. The cost is based on when you pay for the first year and the early payment discounted rate for the other years.

The \$50 increase for 2023 onwards is refundable to all members that volunteer for 2 workdays or other organised projects requiring volunteers. Any other price increases in 2023 and 2024 would not apply to you.

Please note, once paid the future amounts are not refundable. if you move or are no longer able to use the club we will not refund any of the payments.

CSSA.

Many members also belong to various firearm/hunting organisations, and we encourage you to support as many of those organisations as possible to help ensure the future of our sport.

At this club CSSA membership is mandatory, if you have already paid for all of 2022 then you do not have to pay again but your CSSA number, expiry date and how you paid must be entered **or your renewal will be rejected.**

If you pay your CSSA directly mid year it is important that you inform us as once your payment is made as your access card will expire on your membership expiry date or CSSA expiry date, whichever comes first.

Please note, if you have a lifetime membership of the CSSA then it only applies to the individual. For family membership, you will have to contact the CSSA directly for family coverage.

Minimum information required.

If you know your membership number (on your membership card) and your details (address, email, phone, etc) have not changed, enter membership number, name, family members names (if family membership) and their details, payment amount, payment method, sign and date the form.

If you do not know your membership number, enter your name and address (we have members with the same first and last names), family members names (if family membership) and their details, payment amount, payment method, sign and date the form.

If any of your details (address, email, phone, etc.) have changed, enter the information specified above plus the changed information in full.

Methods of payment.

Cash can only be used when paying in person or when leaving it in the drop box.

Cheque/Money Order can be used when paying in person, leaving it in the drop box or when sending by mail. Cheques should be made payable to L T V F & G.

EMT/EFT should be sent to renewals@ltvfg.ca A security answer is required. Do not make the security answer your name as that information is often included in the email from Interac. Use something that we have of file such as your PAL or CSSA number, street name, etc. or send a separate email with the answer. Ensure either your name or membership number are included in the message portion of the EMT.

Credit or Debit card can be used when paying in person, to use them online send an email renewals@ltvfg.ca with your completed renewal form attached and we will send you an invoice which includes a link to pay it online via our service provider. **Do NOT send us your credit card number. We do not want or need your card details.**

Forms not signed and dated will be rejected.
